	<p>The purpose of the contract is to provide to Maricopa County with off-site non-emergency care and after-hours and emergency care. Animal Care and Control uses this contract for injured animals throughout the County. In order to provide compliant veterinary care, animals are taken to the nearest veterinarian on contract who is willing to perform services for the County. These animals are often injured and require immediate emergency care before their owners can be identified, contacted, and reunited with their pets.</p> <p>This Contract contains options for contract renewals and is being renewed for a term of two (2) years, thru November 30, 2023. The following vendors will be renewed once all documentation has been received: BluePearl Management LLC DBA: BluePearl Arizona LLC; Integrative Veterinary Oncology Pet Urgent Care, LLC; Waldo Family, LLC DBA: Tempe Pet Clinic. 	<p>This contract provides for the purchase of Boiler Maintenance and Repair Services. The Maricopa County Facilities Management Department, and other County departments, use this contract to provide high-pressure steam boiler, pressure vessel, storage vessel, and hydronic systems maintenance, repair, and replacement, and temporary boiler rental for existing boilers at various Maricopa County locations, on an as-needed basis.</p> <p>This contract contains options for contract renewals and is being renewed for a term of two (2) years, through December 31, 2023.
